Myst Granular can be applied throughout the growing season without damage to turf.

Myst Granular has been formulated to be applied both a split long term application or as a bi-monthly application. For all application programs make first application usually in the spring before the onset of localized dry spot and drought stress.

For best results apply before the onset of turf stress, as part of a managed application program. Myst Granular should be applied by conventional fertilizer spreading equipment.

**WATERING IN:** Watering in is required when Myst Granular is applied at 4 lbs./1,000 sq. ft. Water in immediately after application with at least 1/4" of irrigation.

**Bi-Monthly Application**

<i>Rate/1,000 sq. ft.</i>	<i>Timing</i>	<i>Watering In</i>
2 lbs.	1 initial application in spring before symptoms of LD, then repeat after 7 – 10 days, then repeat every 8 weeks through growing season	No

It is not essential to water in after application but best results will be obtained by watering in 0-18 hours after application.
