Myst Tablets can be applied throughout the growing season without damage to turf.

Myst Tablets are formulated for the spot treatment of areas affected by LDS or drought stress. Myst Tablets should be applied by a hose end wetting agent tablet applicator.

One Myst Tablet should be sufficient to cover one golf green in 20 minutes or alternatively spot treat six golf greens. Myst Tablets will dissolve at different rates dependent on water pressure and temperature.

It is not essential to water in after application.
